Nominees for the Walk of Fame (living or deceased) must have made outstanding contributions and provided significant leadership in one or more of the following areas:

- Government / Military
- Invention / Innovation
- Law
- Medicine
- Philanthropy
- Science
- Significant Personal Achievement
- Sports
- Other

Nominees must be individuals or non-profit groups from the Dayton Region, or individuals or non-profit groups who have spent a significant amount of time in the Dayton Region. The Judging Committee will make final selections based on how the nominee's accomplishments have made an enduring impact on our local community, our region, the nation and/or the world.

Nominations must be received by Noon on March 1, 2018.
